



















A Note from Our Executive Director

Dear Friends of Woodley House,

Although we find ourselves in turbulent, uncertain times, it remains important to pause and reflect on successes and celebrate good news.

We're pleased and proud to say that Woodley House's 2024 was remarkable. Across our programs, we supported more D.C. residents than in any other year in our 66-year history: 497 individuals, an 18% increase over the year before.

We completed our first full year offering case management services as a Permanent Supportive Housing (PSH) provider. Overall, Woodley House's PSH program served 100 unique households, helping 28 of them successfully secure housing during 2024. We continue to support our other PSH participants in navigating the voucher process.

And we opened our fifth standalone residential property, Terry-Pincus Apartments, following extensive renovation of the building. Terry-Pincus offers an innovative program model with both shared apartments and on-site staffing.

It's impossible to say what the future holds. We do know that Woodley House's work, supporting Washingtonians who face behavioral health challenges and the risk of chronic homelessness, is more critical than ever. We cannot stop.

We remain committed to expanding our reach while maintaining the high quality of our programs. Our goal is to serve at least 600 individuals annually by 2030. With your generous support, Woodley House will get there.

2024 Highlights

- Woodley House served **497 individuals** across all programs in 2024, an 18% increase.
- Our group homes Valenti House and Holly House served 31 unique residents.
 More than 90% of group home residents remained stably housed at the end of 2024.
- We served 44 clients in our Supported Independent Living (SIL) program, allowing them to **thrive independently** with ongoing case management support.
- Our Permanent Supportive Housing (PSH) program served **100 households**, including 96 children, helping them **break the cycle of chronic homelessness**.
- The Woodley House Food Pantry fulfilled 665 total orders from 95 households in 2024; this represented a **23% increase** in orders compared to the year before.
- We completed renovations and debuted our fifth standalone residential property, **Terry-Pincus Apartments**, in Ward 4. It served 17 clients after opening mid-year.

Woodley House is growing to serve 600+ individuals annually by 2030.














2024 Financials


Revenue & Support Total = \$4,974,168


- Woodley House, Inc., ended 2024 with an increase in net assets of \$468,600.




